SINA also publishes a newsletter & maintains a web site to further advise about the services we provide and the results of our efforts. SINA sometimes provides services, such as accounting or fiduciary assistance to other organizations and our employees and board members often serve as members for other organizations such as Neighborhood Revitalization Zone planning committees.

(Recognition, Education, Achievement and Community Health) committee annual banquet at which the Neighborhood Service Awards are presented honoring individuals for their efforts in the improvement of the SINA neighborhood, neighborhood safety programs including facilitating the integration of efforts by the security teams at our member institutions and the Hartford Police, donations to the Hartford Police including equipment, providing space to the Aetna Center for Families and the CCMC/UCONN Pediatric & Youth HIV Program which provide services to neighborhood residents, sponsorship of the Hartford Schools Annual Citywide Science Fair where we provide for certain expenses as well as assist in providing volunteer judges for the childrens' projects.

4c (Code:) (Expenses \$ 866,203 including grants of \$ 302,825) (Revenue \$ 548,476) Development programs including: housing, real estate & economic development including: operating 42 Vernon Street a 9 unit low income rental property, maintenance and carrying cost for other properties held for development, providing funding to subsidiaries which are developing either low income rental housing or constructing homes for sale to low to moderate income buyers (all housing efforts are within the SINA neighborhood), 83 units of low income rentals were rehabilitated to date and 55 houses were developed and sold in the homeownership program, sold undeveloped land to other low income housing developers at discounted costs for their projects, economic development efforts such as cooperative efforts with local businesses to provide holiday lighting, pursue funding for projects, funding safety & traffic studies, and involvement in Streetscape improvement projects. Also currently performing a large study for increasing economic development in our neighborhood including Anchor Institution concepts & practices from around the country with nationally know consultants.

rehabilitate and sell a certain property in our neighborhood to low to moderate income homebuyers. A portion of the property surrounding the project needed to be procured through an easement or other method from the other member to provide parking for the project. Southside did evaluate the arrangement and feels it is entirely within our exempt purpose, that we control the activity due to 51% ownership of the LLC, that it is not significant compared to our overall activities, that the transaction is at arm's length and that it will therefore not jeopardize our exempt status. The other member is a property owner and developer who also concentrates many of his efforts within our neighborhood. The arrangement was not entered into before tax research was performed including discussions with our CPA firm, meetings regarding the activity were also held with staff and board members, including our treasurer, and the decision that this arrangement fell under the safe harbor provisions for such transactions was arrived at. The LLC will be dissolved when the rehabilitation is completed and the property is sold to low to moderate income buyers.
